

Doping Control Activities Report

2023

The 2023 TDP is due to the Risk Assessment mainly focused on IC Testing, because the risk of doping is in waterskiing higher during high level competitions, where athletes maybe try to compete even if they are slightly injured.

In 2023, the IWWF RTP consisted of 6 athletes who were each to be tested 3 times OOC (at least one of the tests per Person includes ESA + GHRF). The 6 RTP athletes were selected until 31st of March by random draw out of groups consisting of the best athletes according to the individual disciplines and representing both genders.

According to this this Report includes all Tests performed on IWWF RTP Athletes, all Test performed in competition at Competitions of the Major IWWF Level (World Championships) and at top regional level (European Champinoships, PanAm Championships, Asian Championships etc) and all positive cases concerning Athletes in all Sports under the responsibility of IWWF (even if the RMA was a NADO).
